**RE:** Notification of Amendments to Ontario Regulation 79/10 under  
the *Long-Term Care Homes Act, 2007*

I am pleased to inform you that amendments to Ontario Regulation 79/10 (Regulation) under the *Long-Term Care Homes Act, 2007* (LTCHA) relating to personal support workers (PSWs) will come into force on January 1, 2016. The amendments relate to PSW qualifications, including grandparenting requirements and labour mobility.

Descriptions of the proposed regulatory amendments were posted to the Regulatory Registry for a 30 day posting period between October 21, 2015 and November 20, 2015. All feedback received during the public consultation period was reviewed and carefully considered in the drafting of the final proposed amendments. Minor changes were made from the plain language version of the proposed amendments that were posted for comment on the Regulatory Registry.

The approved regulatory amendments incorporate the Ministry of Training, Colleges and Universities' 2014 new common educational standard for PSWs. Ontario's Public Community Colleges, Private Career Colleges and District School Boards have all started to implement the new common standard. The Regulation has been amended to permit long-term care (LTC) home licensees to hire PSWs who are enrolled in or have successfully completed a PSW program that meets the new common standard.


In addition, the grandparenting provisions have been updated. Individuals who were working as PSWs in a LTC home in the 12-month period prior to July 1, 2011 but who lack formal education qualifications will be required to have current PSW work experience prior to being hired by a LTC home licensee. Individuals who are enrolled in or have successfully completed a program under one of the three former educational standards will be grandparented.

The Regulation now provides labour mobility for PSWs who have a diploma or certificate granted in another jurisdiction from a program that was a minimum of 600 hours (counting both class time and practical experience time) and who have, in the opinion of the licensee, skills that are equivalent to those expected of PSWs who have completed a program under the new common educational standard. Finally, registered nurses or registered practical nurses being hired as a PSW in a LTC home will be required to have the appropriate certificate of registration with the College of Nurses of Ontario.

LTC home licensees, staff and PSW students and graduates are encouraged to review the regulatory amendments to fully understand the changes and implications. For full details, please see the Regulation as set out on e-Laws at:
